
The COVID-19 pandemic has been an unprecedented crisis, profoundly affecting the global community, including LIFT International.


LIFT Impact at a Glance

INTELLIGENCE

LIFT Analysts serve as the entry point for information reports that we receive from partners. We collect, collate and decide on the next step (whether to take action or not). Each piece of information we receive is stored and the data helps us paint a bigger picture of trafficking in the region and allows us to track patterns of traffickers. Additionally, our analysts help law enforcement officers with complex crimes by extracting and analysing information and then creating reports from the internet, mobile devices, social media profiles and other digital platforms.

In 2020 we received 204 information reports and opened 33 new cases.



INTELLIGENCE HIGHLIGHT: CASE TULIP

An Israeli foreigner living in Thailand evaded the justice system for years. Via social media channels, he openly sought relationships with mothers of young children, with open intentions of abusing the children. LIFT and our law enforcement partners at DSI* worked hard for several months to gather proper evidence to warrant an arrest.

To build a clear case, LIFT analysts gathered evidence to prove that the perpetrator had clear intentions to sexually engage with the children of Thai mothers he met online. We then were able to present a comprehensive case to the Human Trafficking division of DSI that was sufficient for a search warrant.

At the arrest, LIFT provided a detailed forensic analysis of the offender's cellular equipment and other electronic devices which turned out to reveal a significant amount of child sexual abuse material (CSAM). He was charged by both the immigration department of the Royal Thai Police as well as the human trafficking division for possession of CSAM.



INVESTIGATION

Often an information report comes in that has enough information to raise alarm, but not enough to give to the police with the certainty that they have sufficient evidence take the case forward. At this point, our fieldworkers step in at the request of analysts and work tirelessly to gather enough evidence to confirm the information report that was submitted. Our fieldworkers obtain evidence via photography, surveillance and other appropriate methods to confirm whether or not the information is correct. If the information is confirmed, the case is sent directly to law enforcement. At this time our fieldworkers move to a support role to assist law enforcement with the case.







INVESTIGATION HIGHLIGHT: CASE STEP

Royal Thai Police brought a case to LIFT in which a convicted human trafficker* was suspected to be selling boys to customers at a popular tourist hot spot in town. LIFT Investigators deployed to survey the area and gather evidence to support the information report we received from police.

With the assistance and input from LIFT social workers at all times, LIFT investigators were able to interview one of the victims to support their findings.

A 14 year-old boy had come to the city to work at his aunt's restaurant. He was a few days late arriving and missed his opportunity to work. The offender found him walking the streets looking for work and began to sexually abuse and coerce him, reacting in anger if the boy resisted. The boy was taken to one of our partner shelters for safety.

"After the offender was arrested, the victim thanked our team several times for helping him out of the helpless and threatening situation. By giving up our time for a few weeks, months or even a year can bring a drastic change to someone else's life, their 'entire' life, to end the sufferings forced upon the innocent, paving a new path where they can get another chance to live." --LIFT Case Team Leader

PROSECUTION

From the moment we receive an information report to the second a survivor moves back home, LIFT Legal works to ensure best practices are met. Our legal team ensures LIFT follows the letter of the law and they assist police with legal services (search warrants, consultations) and by helping direct case work to ensure the case will hold up in court and have the best outcome for victims. Additionally, our lawyer works with public prosecutors and victims for compensation claims, civil applications, appeals, interviews, victim representation, and to assist inside the courtroom. In the event that the judicial system fails a survivor, our lawyer steps in to seek justice on his/her behalf.

In 2020 LIFT Legal helped to achieve 34 convictions, resulting in 1297 years of imprisonment.



PROSECUTION HIGHLIGHT: CASE ARIEL

CASE ARIEL spanned throughout 2020. A 13 year-old girl was being raped repeatedly by her neighbour who was recording his crimes and using the videos to threaten and manipulate the victim for two years. He may have been selling the content online. The victim finally broke down to a teacher at school and the teacher reached out to LIFT for help.

When we say LIFT Legal is a part of the process from beginning to end, this case is the perfect example. Our lawyer, Wiliyasinee "Pik" Rinya, was on the ground across the country, staying days with the family in order to gain the girl's trust in order to gather proper evidence to prosecute the offender to the full extent of the law. Pik made regular visits along with LIFT social worker, Janejinda Pawadee, to ensure the safety of the victim and her family now and in the future.

Because of her work on this case, Pik was invited to give a lecture to the Royal Thai Police and the Department of Provincial Administration (DOPA) on how to properly conduct a case to claim compensation for victims. The inquiry official of this case was included among the attendees.

Of the victim Pik said, "I saw the future of Thailand in this victim. She is a grade A student, a good girl. She could be a doctor or a lawyer and I want to support her as much as possible. We can heal her and give her justice." Pik went on to say that she is not just a lawyer but that she will do everything she can.



SURVIVOR CARE

LIFT Social Workers work throughout all of our operations to ensure that LIFT and anyone we partner with treats victims with the best care. LIFT aims for a Victim-Centered Approach in everything we do and our social workers champion this in all the areas of our work, including within our partnerships.

Our social workers advise LIFT Analysts and our collections team during their work and once we take on a case, they help police choose the best approach to handle casework with victim welfare in mind. They also conduct victim interviews for police and attend terminations to ensure that victims know their rights and that they get placed in the best shelter for their needs. Throughout the court process, LIFT Social Workers are present to ensure victims are not re-traumatised and that they receive the justice they deserve in the form of compensation. After court proceedings resolve, LIFT Social Workers stay in contact with survivors to ensure they remain on

the path to recovery and assist in obtaining scholarships, job training, housing and more as

needed.



SURVIVOR CARE HIGHLIGHT: CASE SURIN

Seven victims were removed from harm in early 2020 when LIFT investigators assisted the Department of Provincial Administration (DOPA) in arresting 4 offenders who owned 3 interconnected karaoke bars in a small country town near the Thai-Cambodian border. The karaoke bars were shut down and the victims, ranging in age from 14-17, went to a government shelter in the province to wait out the prosecution process.

LIFT social worker, Chutinate "Chu" Arsakit said this case was a first for LIFT International to have direct interaction with the MSDHS* Anti-Trafficking Unit, which resulted in much more clear communication regarding case updates and the victims' futures. Usually the communication goes through a liaison at the shelter and details get missed or lost completely in transition. With direct contact, Chu was able to get a formal, extensive report which enabled our social work team to assist the victims more thoroughly, specifically and individually.

"I am proud that my social work is driven by both NGO and government partners. We communicate well to coordinate, refer and follow up regarding the social work and legal processes. The survivors of this case were given appropriate service and can start their lives according to their life plan."

Chu went on to say that this new communication path shows that the MSDHS Anti-Trafficking Unit trusts LIFT to support them. "The government has certain restrictions and limitations, but LIFT can help the victims beyond what the government can provide."




INCOME

In 2020 LIFT International's income took another small step forward from 2019. TearFund New Zealand remained a major income source whilst we continued to look to diversify our income portfolio by deepening our partnership with existing funders and bringing new sources of income on board. During the 2nd half of the year we experienced a regression of income due to the global, and localized, impact of Covid-19; yet, LIFT International continues to work closely with a range of partners to access funds. This year has seen the beginning of our parntership with Magnuson Trust and a continuation of our collaboration with Flow Foundation, Porticus, Justice & Care, Dove Trust, CEDAR Fund, and Ping Pong-A-Thon to deepen the impact of our core activities to combat human trafficking.


Over 50 regular and single-gift donors form the foundation of LIFT International's individual giving programme. The majority of these supporters make consistent, monthly donations whilst some individuals make larger one-off contributions per annum.

EXPENSES

The total expenses on activities to combat human trafficking in 2020 was NZD 1,458,631.

Expenditure on our activities to support Thai Law Enforcement to fight human trafficking and our work to operationalize our Intelligence Hub approach remained highest due to LIFT International's strong focus on case work.

We saw the impacts of COVID-19 disrupt our implementation of case work, resulting in less expenditures as the year unfolded. Additionally, with the knowledge of the widespread effects of the pandemic on global economies, we anticipated the possibility of some reduced funding in the year(s) to come, therefore we are looking to keep a sufficient reserve should this come to unfortunate fruition.

During the course of the year, we furthermore recognised that fundraising investment was low which could compromise LIFT International's future. Efforts to develop a sustainable foundation to strengthen our project-based programming and fundraising increased during the 2nd half of the year with among others the recruitment of a new Head of Programs and the preparation of new project ideas.
